As current assets move to commercialization, the team will continue to target and acquire additional digital media assets with proven execution teams.

MotionPix will continue to source future games opportunities in collaborations with Hollywood studio film franchises
- Founding Shareholder of \$350K into TinyRex Games led by an experienced team that plans to develop and release three idle genre mobile games which will leverage their recent partnership with East Side Games. The first major title, Wizard of Oz, is scheduled for worldwide release in Q1 2022 on iOS and Android
- Founding shareholder in Got Game Hub Srl, a European based broadcast and streaming channel that will focus on the gaming, esports and digital media world. This channel will provide 24/7 media content that will be translated into multiple languages and available on several media platforms
